This means real estate investors cannot deduct property tax losses against non-passive income such as W-2 salaries, business income, gains, IRA distributions, etc. If the investor's adjusted gross income (AGI) is above \$150,000 they will not even be allowed the \$25,000 exception for deducting such losses.

The fairness tax is a separate assessment at a rate of 5.15% (5% increased with 3% crisis surtax) borne by the company distributing the dividends.

Leverage: Many investors use debt leverage to buy real estate. This means, for example, \$100,000 can buy four properties at \$25,000 down instead of just one property for \$100,000. Leverage magnifies the profits mentioned above (and potentially the losses). Plus, interest on debt is deductible as a business expense.

A REIT that does not file its tax return by the due date, including extensions, may be penalized 5% of the unpaid tax for each month or part of a month the return is late, up to a maximum of 25% of the unpaid tax. The minimum penalty for a return that is over 60 days late is the smaller of the tax due or \$210.
